The competition is open to model pilots who are in possession of an FAI sporting license for the competition year 2025.

Each participant must be in possession of a valid owner's liability insurance for aircraft models, which fulfills §§ 102 LuftVZO and 37 LuftVG and must present proof of this on site on request.

Model identification according to DVO (EU) 2019/947 Artikel 14.

All participants with 2.4 GHz systems must carry the obligatory declaration of conformity for their RC system with them and show it on request when registering on site. Participants who do not use a 2.4 GHz system must specify at least two permissible frequencies.

By registering, the participant acknowledges that in case of model damage he cannot make any claims against the organizer, executive club or other participants.
